If it can be done safely without proposing threats to neighbors it is a wonderful resource. Unfortunately in our county, we are too densely populated for this to be a practical option.

We feel that long term repercussions will inhibit the growth of our community and that the majority of people will be exposed to negative impacts of the turbines rather than positive ones when forced to live so close to the turbines. We are concerned about negative health impacts due to noise, air turbulence, and shadow flicker. We do not want to experience the annoyance of the audible noise, infrasound, ice throw, or shadow flicker anywhere on our properties. We do not want the property values of our homes and properties to depreciate due to neighboring properties allowing installation of industrial wind turbines. We do not want to have the remains of decommissioned wind turbines littering our county once the project is over. Finally, we do not want to have to endure roadways that have been compromised as a direct result of any type of heavy hauling during the life of the project. Although we recognize the rights of land owners to do as they wish with their own properties, we do not believe this right should extend so far as to impede on the rights of non-participating land owners. The installation of the wind turbines will set limiting constraints on new developments on neighboring properties due to interferences with wind turbine setback ordinances.

We the undersigned request from our county officials that you place a ban that will not allow the development of an industrial wind farm or industrial wind turbines in the area of Posey County at this time or in the future by any company interested in doing so.

PETITION

We the undersigned request from our county officials that you change proposed setback ordinances to no less than 3,280 feet from property lines, allow zero shadow flicker on non-participating properties, allow noise levels not to exceed 32 dBa at non-participating property lines, and guarantee property values will not depreciate. We also ask that a mandatory bond or bonds be put in place prior to construction of any and all wind turbines that will cover 100 percent of the FUTURE PROJECTED COSTS of decommissioning at the end of the turbines' service life. Finally, we ask that the wind turbine company be held financially responsible for MAINTAINING all roadways that incur damage as a direct result of any aspect of road usage by the turbine company during the entire life of this project. We ask road conditions be maintained to a standard that Posey County officials deem acceptable if road damage is incurred during any time throughout the life of the project. This includes initial installation, routine or non-routine service and maintenance, as well as decommissioning.

At this distance ordinance and other listed constraints, the negative impacts should be minimal enough that participating land owners can enjoy the monetary gains they will receive from wind turbine construction and ensure that non-participants will not have to endure the negative impacts of proposed turbines.
